### **Terms and Conditions**

Terms and conditions upon which **Ready Chef Go Pty Ltd**, hereinafter more particularly referred to as “The Company”, may supply goods or render services on credit to any person or corporate body or organisation or institution, hereinafter more particularly referred to and included in the term “The Applicant”.

1. All goods and services supplied by the Company to the Applicant on credit shall be paid in full by the applicant on or before the \_\_\_\_ day from invoice.
2. The Company will be at liberty to charge a service fee on all accounts overdue. If charged, the service fee % charged is shown in each invoice and will apply monthly and will be added to the account.
3. The Company will reserve the right at all times to suspend the supply of further goods or services on credit to the Applicant without having to give reason for its actions to the Applicant or its agent.
4. The Company will render to the Applicant a statement of account at monthly intervals and that in the event of any charges appearing on the statement of accounts being disputed by the Applicant notice of such dispute must be advised to the
5. In the event of any charges alleged to be in dispute the Applicant will pay for all other charges appearing on the statement of account pending an investigation of the charge or charges so disputed.
6. Credit facilities granted on the basis of information provided in this application are not transferable without the written approval of the Company. The Applicant shall immediately notify the Company in writing upon any change of the proprietors, shareholders, or directors of the Applicant or any information set out in this application, of such change, and the Applicant shall indemnify the Company for any loss arising from the Applicant’s failure to so notify.
7. Title to goods supplied by the Company to the Applicant does not pass to the Applicant until such payment is not received in full by the Company; the Applicant shall be in possession of such goods as a bailee and shall owe the Company the duties and liabilities of a bailee. The Applicant must store the goods separately from other goods.
8. If the Applicant does not pay for any goods by the due date in accordance with this agreement, the Company, its servants and agents are irrevocably authorised by the Applicant to enter any premises under the Applicant’s control or the control of the Applicant’s agents where such goods are stored and use reasonable force to take possession of such goods without liability for the tort of trespass, negligence or payment of any compensation to the Applicant or anyone claiming through the Applicant whatsoever.
9. If the Company incurs any legal or other costs in relation to collection of outstanding amounts from the Applicant, the Applicant will be responsible to repay to the Company or Agent of the Company any such costs.
10. Any notice or demand required to be served, given or made under this agreement shall be sufficiently served on the Applicant or Company if addressed to the Applicant or Company (as the case may require) and posted by ordinary mail addressed to the addressee at its usual or last known place of business and shall be deemed served two days after having been posted.
11. The Company shall not be liable for non-supply of services and under no circumstances shall the Company be liable for any loss, damage or delay occasioned to the Applicant arising from non-supply of the services.
12. If the Applicant is entering into this agreement as a trustee of a trust, then the Applicant represents and warrants to the Company that the Applicant is liable both personally and in its capacity as trustee of the trust and the Applicant has power and authority as trustee of the trust to enter into this agreement and is doing so for a proper purpose. Further the Applicant is entitled to be indemnified fully out of the trust property for its liabilities and obligations as trustee under this agreement before the claims of the beneficiaries.
